Crimestoppers: Sgt Chris Geen had advised that the leaflets had not yet gone out, neither has an invoice been received.

Gyosei Canalside Site: We understand that a meeting has taken place to discuss the latest drawings. The Parish Council was not made aware of this meeting and a letter of complaint will be sent. It appears that an application will now be submitted, based on the last drawings, the Parish Council will make their comments during the consultation period.

06/01531 74 Cantle Avenue, Downs Barn Circumstances for the application as described in the letter, do not justify the proposal which is an over development of the site. There is also concern about the boundary and whether the extension will encroach onto the adjacent woodland. To request that Development Control carry out a site visit., to also ask if this application is approved, that a condition be inserted stating that the extension may only be used by close family members.

06/01530 14 Broadway Avenue, Giffard Park The front extension is totally out of keeping with the area, and could block the vision for traffic leaving Snowhill Court. There appears enough room to extend at the rear.

06/01504 Canal Villa, Marsh Drive, Great Linford Application for tree lopping, to ask that this is restricted to re-shaping and is carried out sympathetically by a qualified tree surgeon.

06/01458 88 Cantle Avenue, Downs Barn To request some professional drawings as the ones provided are completely inadequate and leave a lot of unanswered questions. There is concern about the parking arrangements and proposed new garage.
